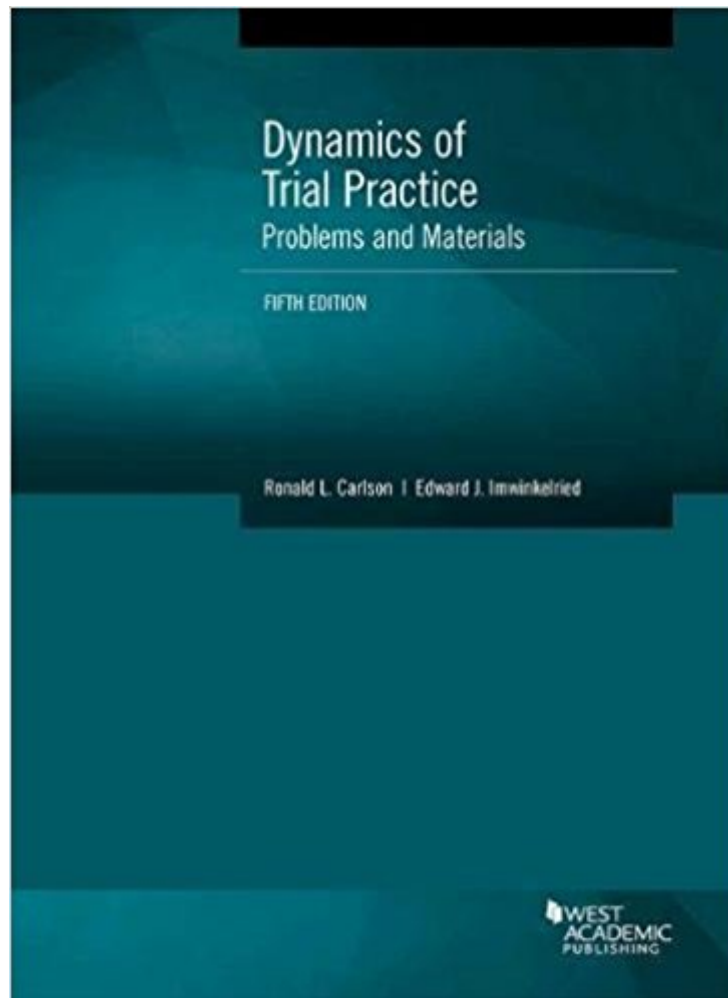

This trial practice book devotes an entire chapter to the concept of strategic case evaluation and integrates that concept into the discussion of every stage of the case. The text contains a large number of casefiles. Near the end of the chapter, the REMINDER poses questions to the students to enable them to determine whether they have grasped the key material in the chapter.
