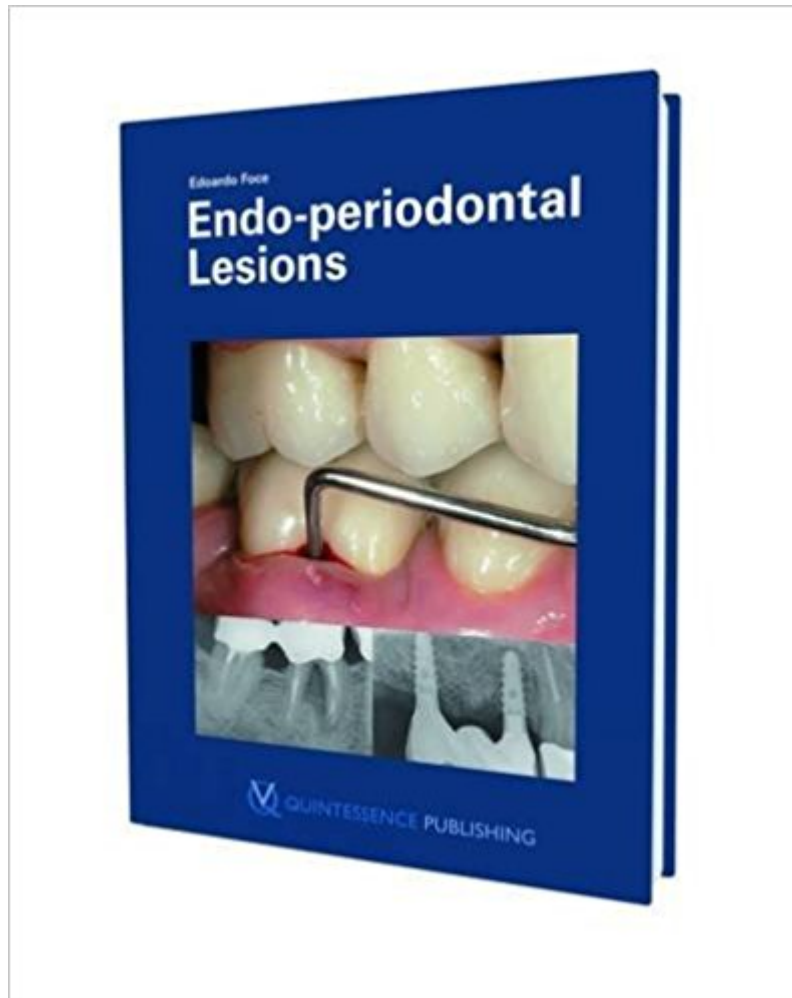

Endodontic and periodontal lesions can manifest identical symptoms despite originating from separate pathogens, and traditional classification has reinforced etiological imprecision in both diagnosis and treatment. Supported by a thorough analysis of the diagnostic, etiopathogenic, and clinical factors, the author of this succinct book proposes new terminology and a simplified classification of endo-periodontal lesions that shed light on an ambiguous pathologic situation that is often misinterpreted in clinical practice.
